**SKYLINE BUILDING SYSTEMS INC. (SKYLINE) WARRANTS TO THE ORIGINAL PURCHASER, THE ROOFINGSERIES MEMBRANE TO BE FREE FROM MANUFACTURING DEFECTS WHICH RESULTS IN WATER LEAKAGE DURING THE TEN (10) YEAR WARRANTY PERIOD, AS INSTALLED ON THE UNITS WITH THE FOLLOWING SERIAL NUMBERS AND KNOWN ADDRESS: (OPTIONAL)**

The Owner acknowledges by accepting this warranty that:

1. This warranty applies only to leaks caused by defects in the RoofingSeries membrane supplied by Skyline, and not to any leaks otherwise caused. Specifically not leaks caused by improper construction or improper installation of the membrane.
2. This warranty shall come into effect only after Skyline has been paid in full for the RoofingSeries membrane.
3. The RoofingSeries membrane must have been installed in accordance with RoofingSeries application instructions, using only RoofingSeries adhesives, components and accessories.
4. This warranty is non-assignable.
5. Skyline shall have no obligation under the terms and conditions of this warranty if the roof membrane has not been reasonably maintained.
6. Skyline shall be liable only for remedies as set out herein, and not for any incidental or consequential damages which may arise from any leaks.
7. Skyline shall have no obligation under the terms and conditions of this warranty if the owner is unable to provide proof of the purchase date of the RoofingSeries membrane and the original purchase price.
8. Skyline shall not be liable in the event that the RoofingSeries membrane is rendered defective by, or is subject to, gales, hurricanes, lightning, tornadoes, hail, accident, alteration, improper installation, abuse, negligence, contact with harmful chemicals, incompatible materials, inadequate design, structural deficiencies, environmental hazards, Acts of God or fortuitous events.

All claims under this limited warranty must be made in writing to Skyline within 30 days of discovery of the leak caused by the alleged defect. Skyline must be allowed a reasonable opportunity to inspect, if Skyline so desires, any of the alleged defects before repairs or replacements are made. Any defective membrane may, at Skyline's option, become Skyline's property or be disposed of by the owner.

If leakage is found to be due to manufacturer's defect, and occurs within 15 years of the date of purchase, subject to the terms and conditions expressed herein, Skyline will at its option:

A) Provide replacement membrane for such defective membrane at the original location of installation;

OR,

B) Provide a credit on prorated basis, towards the purchase of new membrane based on the remaining months of unexpired warranty and the original purchase price, as per the following formula. Months of remaining warranty period divided by the number of months or original warranty period, multiplied by the original price.

This warranty is in lieu of all other warranties whether expressed or implied and whether statutory or otherwise. No representative, agent or employee of Skyline is authorized to give any warranty or guarantee other than as expressed herein.
